Message from the Executive Director

I joined Chimo in August and have done a deep dive into what it means to be Chimo – the rich 45 years of history, the legacy, all the tireless volunteers and staff who dedicate so much of themselves.

My primary focus has been ensuring we honoured that legacy and Chimo's origin in crisis work as we forged ahead, deepening relationships with our community partners and funders. We also continued our work with the City of Richmond to address homelessness and the affordable housing issues facing Richmond residents.

This year saw Chimo receive three-year CARF accreditation. We continue to assess and evolve our best practices to ensure compliance and the best service for our clients. Launching our new Family Law Advocate Program has allowed us to expand our suite of legal advocacy services. We are grateful for the generous funding from the Law Foundation, which has provided this opportunity to expand both our Outreach and Advocacy Program as well as our Legal Advocacy Program.

Our year ahead will focus on implementing a a strong strategic way forward as we continue to focus on our 5th.

Organizational and Financial Strengths

I am the Treasurer for Chimo Community Services ("Chimo"). I would like to provide an overview on the organization's performance and accomplishments in the past fiscal year.

The financial performance of Chimo has further improved for the fiscal year ended March 31, 2019. Our revenue came in at approximately \$2.12 million, about \$75 thousand higher than prior year. This is mainly due to additional grants received for

our Law Foundation program.

Our expenses for the year was approximately \$2.01 million, consistent with prior year.

As a result, the organization ended the fiscal year with a net surplus of approximately \$107 thousand, prior to amortization.

Accomplishments in 2018/2019 include: Worked with over 948 clients in the Outreach and Advocacy program, with services in 12 different

languages; provided clients with free guidance, support, and legal service.

HPP and HOP served 112 clients and provided 265 rent supplements during 2018/2019.

The number of calls taken at Crisis Line 11,849. The new Settlement Program served 369 clients and delivered 100 workshops.

Increased utilization of our facilities at Nova House serving 153 women and 70 children.

Delivered 139 workshops to high school students in Richmond.

Report on the Financial Statements: Opinion

Basis for Opinion

We are independent of the Society in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with those requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Annual Report

Our opinion on the financial statements does not cover the annual report and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the annual report and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of the annual report, we are required to report that fact. We have nothing to report in this regard.

Other Legal and Regulatory Requirements

As required by the British Columbia Societies Act, we report that, in our opinion, the Society's financial statements have been prepared following Canadian accounting standards for not-for-profit organizations.

Responsibilities of Management and Those Charged with Governance for the Financial Statements Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Society's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Society or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Society's financial reporting process.
